- 1. The intending bidder must agree to terms and conditions of CPWD Form 6 & 8. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 2. Information and Instructions for bidders posted on website shall form part of bid document.
- 3. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/GOA.
- 4. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- 5. The intending bidder must have / obtain a valid Class-III digital signature to submit the bid.
- 6. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 7. Bidder must ensure to quote rate of each item.
- 8. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".
