Appointment of Mine Developer cum Operator (MDO) for Development, Operation and Mining of the Dongri Tal-II (Phase-I) Coal Block situated at Singrauli Coal Field, District Singrauli, Madhya Pradesh, India

Goa Industrial Development Corporation (GOA IDC), a Government of Goa undertaking (the "Authority") has been selected for the Dongri Tal-II (Phase-I) Coal Block, Singrauli Coal Field, District Singrauli, Madhya Pradesh, India for commercial exploitation. Accordingly, GOA IDC has entered into an Allotment Agreement with the Ministry of Coal, Government of India. In this regard, the Authority has decided to undertake the development and operation of the mine through a Mine Developer and Operator (MDO) for extraction of coal through open cast method and delivery thereof to the Authority.

Mineable Reserves: The total geological reserves are 43.274 MT and mineable reserves are 37.986 MT. The stripping ratio of the mine is 15.73 Cum / Tonne, while the Coal grades are B-D Grade, G-3 to G-8, GCV 6454 – 5089 K Cal/Kg. The peak production capacity of the mine is 2.9 MPTA.

Project Duration: 21 years (including development period) or Life of mine, whichever is earlier

Bidding Process: Proposals are invited (Single Stage – 2 Parts (Technical & Financial)) as per the RFP Criteria from interested National / International bidders either as a single entity, bidding group or as a consortium for selection of the MDO.
